_____ (initial) I understand that I will earn 60% of my gross sales, less a \$12.00 Consignor Fee, for participation in the JBF Franchisee sale. I understand that Consignors who help with the sale for four (4) hours will earn an extra 5% of his/her gross sales and consignors who help with a minimum of 8 hours at the sale will earn an extra 10% of his/her gross sales.

(initial) I verify that no item I am consigning is the subject of any current, pending or threatened recall notice according to the Consumer Products Safety Commission, or if any of my items were part of a recall, any repair made is by the original manufacturer or made in accordance with the original manufacturer warranty program. If a refund is made to a shopper due to a product not working, missing parts or a defect, I understand that I, the consignor will not be paid for this item. It is recognized that "all sales are final," however, it is illegal on the consignors behalf to offer for sale, a recalled item.
